Charles Stull made a motion to approve Resolution 1 of 2023 for supporting the Pennsylvania Commission for the United States Semiquincentennial.

Sharon Long, Secretary Treasurer, brought up about the donation of property in Georgetown that a resident would like to give to the township. It consists of 3 small lots. Jeremy Smail made a motion to have Tim Miller, Solicitor, look into this to see if we are even allowed to take it. Kris Kulick seconded. Motion carried.

Sharon Long, Zoning Officer, read the zoning report. Jeremy Smail made a motion to approve the report. Kevin Miller seconded. Motion carried.

Ted Long, Foreman, was read his road report for the month. Kris Kulick made a motion to approve the report. Jeremy Smail seconded. Motion carried.

VISITORS:

Spurgeon Schilling of New Bethlehem stated that he is an independent SEO (Sewage Enforcement Officer) that used to work for Armstrong Sewage Enforcement Agency since 2007. He states that the services that we are used to seeing will remain the same but we would no longer be paying a fee to the county enforcement agency instead the township would receive \$100 for each permit. He will be placed on the agenda for next months meeting so that he can go into further detail.

Rob Pastva of 127 Sportsman Road spoke representing the park that they would like to be kept in the loop of the possible acquisition of the park that so far the county is not keeping them informed.
